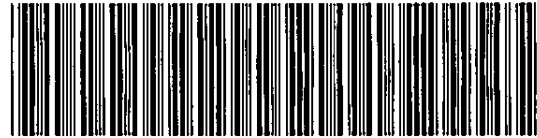

- FIRST: The name of the Corporation is SANGER OF NORTH FLORIDA, INC..
- SECOND: The Articles of Organization of the Corporation were filed on May 3, 1965 and assigned document number 708911 and amended on April 1, 2015 and assigned document number H150000809153.
- THIRD: The dissolution was approved on MAY 30, 2015.
