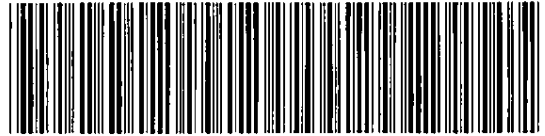

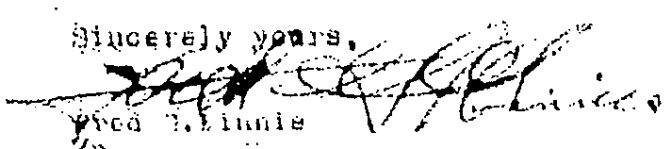

Gentlemen:

The amendment to the charter for Negro Youth Center of Palmetto, Florida is being returned since the charter ~~is not of record~~ here. Presumably, it is still in the circuit court. In this event, the present procedure is to reincorporate. A suggested reincorporation procedure is enclosed for your easy reference.

As you know, Chapter 617, Florida Statutes was completely amended and revised by the Florida Legislature. These changes became effective September 1, 1959. Since it is the intent of Chapter 617 to permit such organizations to update their documents through reincorporation, and all filing and approving authority is now administered by the secretary of state, you will want to reincorporate under the present law.

Gentleman:

Pursuant to your communication of April 20 a review of the file on "The Negro Youth Center of Palmetto, Florida" has just been made.

The records show that the charter was received in this office on January 27 from the offices of Minnie and Williams of Tampa, Florida. Actually, the document is an original of the one received from you which may be considered as a charter or an amendment at this point. The document was returned on February 10 for additional information. It was received and returned again on March 10 for completion of the information requested on February 10. On April 13 we wrote again for compliance to the corporate law and at this point no response has been received.

Mr. Anderson, the problem may be that the reincorporation procedure pursuant to the current Chapter 617, Florida Statutes is taking some time for accomplishment. The document you submitted is an amendment to a charter which is not of record here. Under the old law such organizations were permitted to file their charter with the clerk of the circuit court with prior approval of the Circuit Judge. Chapter 617, Florida Statutes was completely revised and amended by the Florida Legislature. These changes became effective on September 1, 1959. The law now permits such organizations

to update their documents through reincorporation. If the attorney requests a suggested procedure for reincorporation acceptable to this office, we are always glad to be helpful. Of course, this office administers the law and does not act as legal counsel. If the law offices of Minnie and Williams have any questions in this matter, we would be pleased to endeavor to answer them, since all filing and approving authority is now administered by the Secretary of State concerning Chapter 617.

The sales tax exemption numbers are issued by the Office of the State Comptroller. If you are referring to the income tax exemptions, this application must be made direct to the Internal Revenue.

When the filing has been completed we will forward a copy of the articles of reincorporation. There is a fee of \$3 for each certified copy requested.

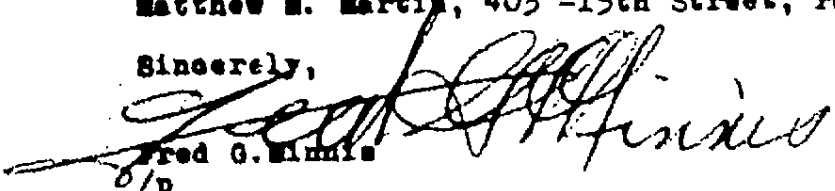

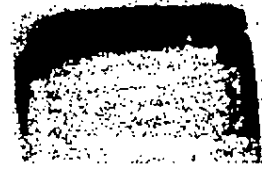

TO THE CHARTER OF THE NEGRO YOUTH CENTER OF PALMETTO, FLORIDA, PREVIOUSLY FILED IN THE TWELFTH JUDICIAL CIRCUIT IN AND FOR MANATEE COUNTY, FLORIDA DURING THE YEAR OF 1957.

The Corporation at its regular meeting under the provision of Section 617, Florida Statutes, as amended reincorporated as a Corporation not for profit, under the proposed Charter:

ARTICLE I NAME

The name of the Corporation shall be "THE NEGRO YOUTH CENTER OF PALMETTO, FLORIDA". The Corporation's address is 403 Palmetto, Manatee County, Florida.

ARTICLE II OBJECTIVE

The general nature and object of this Corporation is to buy, purchase, own, acquire by gift, devise, purchase or otherwise, real and personal property, and to build and construct, provide for, maintain and equip suitable buildings and playing areas, etc., for the benefit, use and occupation of said Negro Youth Center of Palmetto, Florida, its members and all children of the Palmetto, Washington Park Area.

To organize and sponsor various athletic and recreational activities for the benefit of all children.

To sponsor cultural and other types of programs.

To receive, administer, disburse and invest gifts, devises and bequests by or from any persons or Corporations, for the training and educational development of the members of THE NEGRO YOUTH CENTER OF PALMETTO, FLORIDA.

To issue bonds, notes, debentures and evidences of indebtedness, and to secure the same by mortgage, deed of trust, or otherwise.

This Corporation is organized primarily for the purpose of providing recreational and cultural facilities for the use of all Negro minors and adults in the Palmetto, Washington Park Area.

This Corporation shall have no power to mortgage or encumber any property without the written consent and direction of the said Negro Youth Center of Palmetto, Florida, evidenced by resolution of said Youth Center duly passed. This Corporation shall have no power to sell, deed or otherwise dispose of any property without the written consent and direction of the said Negro Youth Center of Palmetto, Florida, evidenced by resolution or motion of said Youth Center introduced at a regular or special business meeting, or conference and duly passed at a subsequent regular or special business meeting. A certificate duly signed by the Clerk of said Youth Center shall be held and taken as sufficient evidence of the actions of said Youth Center as to the due passage of said resolutions. All legal instruments of this Corporation shall be signed by the President or Vice-President of the Corporation, and attested by the Secretary or Acting Secretary of the Corporation.

ARTICLE III MEMBERSHIP

Membership of the Corporation shall be open to all parents or interested adults in the sponsoring of a complete recreational program for the Youth of the Palmetto, Washington Park Area.

The present members of the Negro Youth Center of Palmetto, Manatee County, Florida, and those hereafter admitted to membership in the Corporation, shall constitute the membership of this Corporation.

ARTICLE IV

This Corporation shall have perpetual existence.

ARTICLE V

The names and residences of the subscribers are as follows:

Turners Chapel A.M.E. Church

Palmetto Manatee County, Florida

Reverend E.W. Carey
Providence Baptist Church

Palmetto Manatee County, Florida

Luella S. Hadley, Palmetto Manatee County, Florida

ARTICLE VI

The affairs of the Corporation shall be managed by a President, Vice President, Secretary, Assistant Secretary, Treasurer and an executive Board composed of the President, Retiring President and 7 Directors. Such officers, including Directors, shall be elected at the April business meeting each year, 4 Directors shall be elected on even years, and 3 Directors shall be elected at the April business meeting on odd years.

In case of the incapacity of any member, then a special election will be called to obtain his or her replacement.

All officers shall serve until their successors are elected and installed.

ARTICLE VII

The names of the officers who are to manage all the affairs of the Corporation until the first election or appointment under this Charter are as follows, to wit:

President	Reverend Matthew M. Martin
Director	Reverend E. W. Carey
Secretary	Luella S. Hadley

ARTICLE VIII

The Corporation in its business procedure will be governed by Robert's Rules of Order except wherein at least two-thirds of the members present at a regular meeting should vote to suspend the rules.

ARTICLE IX

and these articles of incorporation:

The by-laws of this Corporation shall be made, altered or amended by the Corporation at any regular or special meeting duly and legally called, but any alterations or amendments of said by-laws or articles of incorporation shall only be made by a four-fifths vote of all the members of the Corporation.

ARTICLE X

The highest amount of indebtedness of liability to which the Corporation may at any time subject itself, which shall never be greater than two-thirds of the value of the property of the Corporation, shall be \$100,000.00.

ARTICLE XI

The amount in value of the real estate which the Corporation may hold shall be \$150,000.00.

ARTICLE XII

"Upon dissolution of this Corporation all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under section 901 (c) (3) of the Internal Revenue Code, or to the Federal Government or State or Local Government, for a public purpose, and none of the assets will be distributed to any member, officer or trustee of this Corporation."

This is to certify that at a regular meeting of the Corporation the above amendment was added to the Charter by unanimous vote of all the members of the Corporation.

CHARTER OF THE NEGRO YOUTH CENTER OF PALMETTO, FLORIDA

TO: The Honorable Judges of the Twelfth Judicial Circuit in and for Manatee County, Florida

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under Section 617.10 Florida Statutes applicable to corporations not for profit, under the following proposed charter:

ARTICLE I NAME

The name of the corporation shall be "The Negro Youth Center of Palmetto, Florida" and it is to be located in Palmetto, Manatee County, Florida.

ARTICLE II OBJECTIVE

The general nature and object of this Corporation is to buy, purchase, own, acquire, by gift, devise, purchase or otherwise, real and personal property, and to build and construct, provide for, maintain and equip suitable buildings and playing areas, etc. for the benefit, use and occupation of said Negro Youth Center of Palmetto, Florida, its members and all children of the Palmetto, Washington Park Area.

To receive, administer, disburse and invest gifts, devised and bequests by or from any persons or corporations for the training and educational development of the members of the Youth Center.

To make, study, organize, investigate and distribute information on the training and educational development of young people.

This organization shall be a society to conduct religious and social activities for the social development of all of the citizens of the Palmetto, Washington Park Areas.

This corporation shall have no power to mortgage or encumber any property without the written consent and direction of the said Negro Youth Center of Palmetto, Florida, evidenced by resolution of said Youth Center duly passed. This corporation shall have no power to sell, deed, or otherwise dispose of any property without the written consent and direction of the said Negro Youth Center of Palmetto, Florida, evidenced by resolution or motion of said Youth Center introduced at a regular or special business

The by-laws of this corporation shall be made, altered or amended by the corporation at any regular or special meeting duly and legally called, but any alterations or amendments of said by-laws shall only be made by a four-fifths vote of all of the members of the corporation.

ARTICLE X

The highest amount of indebtedness or liability to which the corporation may at any time subject itself, which shall never be greater than two-thirds of the value of the property of the corporation, shall be \$100,000.00.

ARTICLE XI

The amount in value of the real estate which the corporation may hold subject always to the approval of the Circuit Judge, shall be \$150,000.00.

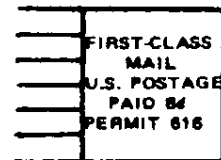

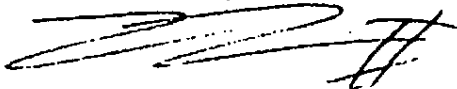

ARTICLES OF AMENDMENT TO SECRETARY OF STATE
TALLAHASSEE FLORIDA

ARTICLES OF INCORPORATION

OF

THE NEGRO YOUTH CENTER OF PALMETTO, FLORIDA.

Pursuant to the provision of F.S. 617 known as the General Non-Profit Corporation Act, and any statute not in conflict with it, should contain in the Florida General Corporation Act, Florida Statute 617, the undersigned corporation adopts, and amends pursuant to Article IX of the Articles of Incorporation, the present Articles of Incorporation as filed with the Secretary of State.

1. The First Article of the Articles of Incorporation is amended to read as follows:

ARTICLE I
NAME

The name of the corporation is PALMETTO YOUTH CENTER, INC.

2. Article Two of the Articles of Incorporation is amended to read as follows:

ARTICLE II
Purpose

The general nature and purpose of this Corporation is to buy, purchase, own, acquire by gift, devise, purchase or otherwise, real and personal property, and to build and construct, provide for, maintain and equip suitable buildings and play areas, etc., for the benefit and use of all youth under the age of 18 located in and about Palmetto, Florida.

To organize and sponsor various athletic and recreational activities for the benefit of all children:

To sponsor cultural and other type of programs for the said children.

To receive, administer, disburse and invest gifts, devises and bequests by or from any persons or corporations, for the training and educational development of all children of all race.

creed, sex, color, national origin, or handicap.

To issue bonds, notes, debentures and evidences of indebtedness, and to secure the same by mortgage, deed of trust, or otherwise.

To provide recreational and cultural facilities for all youth in and about Palmetto and Manatee County, Florida.

Generally, to carry out any act that is not inconsistent with the corporation laws of the State of Florida or any other laws, and any act which the Board of Directors may determine from time to time to do that is in line with the non-profit purpose of this corporation.

3. Article Three of the Articles of Incorporation is amended to read as follows:

ARTICLE III Membership

Membership of the corporation shall be open to all parents or interested adults in Manatee County, who are interested in youth development and recreation. Any individual may become a member by paying a minimal fee as set by the Board of Directors. This is open to all members of all races, creeds, colors and religions.

4. Article Six of the Articles of Incorporation is amended to read as follows:

ARTICLE VI

The Board of Directors is that group of persons vested with the management of the business and affairs of this non-profit corporation subject to the law, Articles of Incorporation, and these by-laws. There shall be no less than six nor any more than seven Directors.

The following people constitute the present Board of Directors to serve until the next annual election.

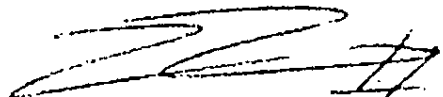

ARTICLES OF AMENDMENT TO THE RESTATED
ARTICLES OF INCORPORATION OF
PALMETTO YOUTH CENTER

Pursuant to the provisions of Florida Statute 617 known as the General Non Profit Corporation Act, and any statement not in conflict with it, the undersigned corporation adopts and amends, pursuant to Article VIII of the Restated Articles of Incorporation, the following Articles of Amendment to its Restated Articles of Amendment:

Article II of the Restated Articles of Incorporation of Palmetto Youth Center is amended to read as follows:

ARTICLE II
Purpose

The purpose for which the corporation is organized is to receive and maintain real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, scientific, literary, or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

Furthermore, to buy, purchase, own, acquire by gift, devise, purchase or otherwise, real and personal property, and to build and construct, provide for, maintain and equip suitable buildings and play areas, etc., for the benefit and use of all youth under the age of eighteen located in and about Palmetto, Florida;

To organize and sponsor various athletic and recreational and educational activities for the benefit of all children;

To sponsor cultural and other types of educational programs for the said children;

To receive, administer, disburse and invest gifts, devises and bequests by or from any persons or corporations, for the training and educational development of all children of all race,

creed, sex, color, national origin, or handicap.

Article IX of the Restated Articles of Incorporation of Palmetto Youth Center is amended to read as follows:

ARTICLE IX

1. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any Director or Officer of the corporation or any member of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no Director or Officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

2. The corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

3. The corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

4. The corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

5. The corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1954, or corresponding provisions of

any subsequent federal tax laws.

6. The corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

7. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code and said Regulations as they now exist or as they may hereafter be amended.

8. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the Twelfth Judicial Circuit, Circuit Division, of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
