TO
ARTICLES OF INCORPORATION
OF
WESTERN HORSESHOW ASSOCIATION OF FLORIDA

ARTICLE II.

PURPOSE

The general nature and object of this corporation shall be:

- (a) To promote, create and stimulate interest in Western/English horseback riding competition primarily among youth 17 years of age and under through judged riding classes;
- (b) To promote the fellowship, good sportsmanship, good character and spirit of competition and cooperation among all horse owners;
- (c) To provide educational, cultural, recreational and social benefits to participants through horseback riding classes to be judged and awarded trophies to the top six competitors in each class;
- (d) To provide a minimum of 51% of all classes to be eligible to youths 17 years of age and under; and
- (e) To codify and enact show rules of the WESTERN HORSESHOW ASSOCIATION OF FLORIDA and to promote all shows under the jurisdiction of this corporation.
