# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF McGREGOR BOULEVARD CHURCH OF CHRIST, INC., a Corporation Not for Profit

Pursuant to the provisions of Section 617.1001 through 617.1006 of the Florida Not for Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

- 1. The name of the corporation is McGregor Boulevard Church of Christ, Inc..
- 2. The following Amendment to the Articles of Incorporation was adopted by all of the Board of Elders and all of the members of the Corporation eligible to vote by the execution of written statements manifesting their intention that such amendment be adopted, (see attached Exhibits A and B) in the manner prescribed by Section 617.1002 of the Florida Not for Profit Corporation Act:

### Amendment I Article I of the Articles of Incorporation is amended to read as follows:

Article One: The name of the corporation is Gulf Coast Church of Christ of Southwest Florida, Inc. A corporation not for profit.

3. The foregoing Amendment shall become effective and the Articles of Incorporation shall be deemed to be amended thereby upon the filing of these Articles of Amendment by the Department of State.

### NAME CHANGE PROPOSAL

The leadership of our church family today proposes to the congregation a name change that would unify both the McGregor Boulevard and Estero locations under one name. The proposal is that we be known as:

Gulf Coast Church of Christ
on McGregor Boulevard

and

Gulf Coast Church of Christ at Estero

The leadership believes this change would be wise for at least four reasons:

- 1. We are continually being confused with McGregor Baptist. The name change would end this confusion.
- The new name would have immediate name recognition as it identifies with the new university (Florida Gulf Coast University).
   This will be a particular advantage in Estero, but there are benefits for both locations.
- 3. We are now a regional church and have been for some time. We have members from Port Charlotte, Punta Gorda, Labelle. Immokalee. Naples, and Lehigh Acres. The name change would give us a regional identity rather than just a local street identity.
- 4. Both locations of our properties would have the same name. This would eliminate confusion and help with any advertising/Bible Hotline/image work we do in the four-county region. If we retain the current names, it will make that job more difficult.
