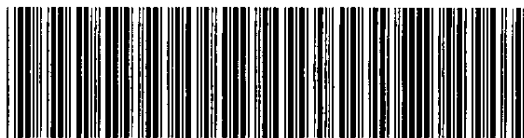



ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION
OF FIRST CHURCH OF CHRIST, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Not
Profit Corporation Act, the undersigned corporation adopts the following Articles
Amendment to its Articles of Incorporation:

1. The name of the Corporation is FIRST CHURCH OF CHRIST, INC.
2. Amendment to Name of Corporation. The present name of the
corporation is FIRST CHURCH OF CHRIST, INC. The name of the corporation is
