ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NORTH SHORE MEDICAL CENTER, INC.



- 1. The name of the corporation is North Shore Medical Center, Inc.
- 2. The following Articles shall be amended to read in their entirety as follows:

ARTICLE I NAME

The name of the corporation shall be North Dade Medical Foundation, Inc. (the 'Corporation').

ARTICLE II OFFICE AND REGISTERED AGENT

The Corporation shall have and continuously maintain in Dade County, Florida, its registered office and a registered agent thereat, upon whom process can be served. The street address of the registered office is 1100 N.W. 95th Street, 4th Floor, c/o Administration, City of Miami, County of Dade, State of Florida 33150; and the name of its registered agent at such registered office is Sandra R. Giblin.

- 3. These amendments were validly adopted by the Board of Directors and by the Sole Member of the Corporation on November 26, 1996.
- 4. The number of votes cast by the Sole Member of the Corporation to amend the Articles of Incorporation was sufficient for approval.
