**ARTICLES OF AMENDMENT TO
AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
THE HOME ASSOCIATION, INC.
(a Florida Not For Profit Corporation
Document Number 710446)**

Pursuant to the provisions of Section 617.1006, Florida Statutes, The Home Association, Inc., a Florida Not For Profit Corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation.

FIRST: There are no members or members entitled to vote on this amendment. Pursuant to Article V of the Corporation's Amended and Restated Articles of Incorporation, the following amendment to the Amended and Restated Articles of Incorporation was adopted by Written Consent of the Board of Managers of the Corporation effective as of December 17, 2024.

SECOND: Article 1 of the Amended and Restated Articles of Incorporation of the Corporation, is deleted in its entirety and the following is substituted therefor:

**ARTICLE 1
NAME**

The name of the corporation shall be:

Tampa Legacy Elder Fund, Inc.

THIRD: Except as aforesaid, the remainder of the Amended and Restated Articles of Incorporation, as previously amended, shall remain in full force and effect and shall not be modified by this Amendment.

FOURTH: The foregoing amendment to the Corporation's Amended and Restated Articles of Incorporation will become effective upon the filing of these Articles of Amendment to Amended and Restated Articles of Incorporation with the Florida Department of State.
