

## AMENDED and RESTATED ARTICLES of INCORPORATION of <a href="https://doi.org/10.1007/jhp.nc">THE FORT CHRISTMAS BAPTIST CHURCH, INC.</a>

Pursuant to Section 617.1002, located in Title XXXVI of the Florida Statutes, the following Articles of Incorporation of the above named Corporation Not For Profit are amended and restated in their entirety:

#### **ARTICLE I: NAME**

The name of this Corporation Not For Profit shall be THE FORT CHRISTMAS BAPTIST CHURCH, INC.

#### **ARTICLE II: PRINCIPAL OFFICE**

The principal office of this Corporation is located in Orange County at 23600 East Colonial Drive, Christmas, Florida, 32709.

#### **ARTICLE III: PURPOSE**

The purpose of this Corporation is to glorify the Lord Jesus Christ by instilling a thorough knowledge of the Lord Jesus Christ within as many people as possible using biblical means. That purpose includes Christian worship, sharing the Gospel of Christ in evangelization, teaching the Holy Scriptures to all people and upholding the local church in obedient, holy living. This Corporation is organized exclusively for religious, charitable, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IV: TERM of EXISTENCE**

The existence of this Corporation shall be perpetual.

#### **ARTICLE V: DIRECTORS**

The selection, number, term, authority, duty and removal of Directors shall be specified in the Constitution and Bylaws of this Corporation.

#### **ARTICLE VI: RESTRICTIONS**

No part of the assets or net earnings of this Corporation shall inure to the benefit of, or be distributable to its Members, Directors, or Officers, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make

payments and distributions in furtherance of the purposes set forth in Article III. This Corporation shall not have capital stock or shareholders.

Whereas this Corporation shall not engage in political campaigning on behalf of or in opposition to any candidate for public office, it shall observe the biblical mandate to endorse and promote righteousness and to identify and rebuke sinfulness. To do less would be a repudiation of our purpose in Article III.

This Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE VII: MEMBERS**

The qualifications, duties, voting, rights, privileges, discipline and termination of members shall be regulated by the Constitution and Bylaws of this Corporation. No vote taken by this Corporation's members is binding upon its Directors or the church Board of Elders.

#### **ARTICLE VIII: POWERS**

This Corporation shall have all the rights and powers customary and proper for Corporations Not For Profit, including the powers specifically enumerated in Chapter-Section 617.0302 of the Florida Statutes. All such powers are subject to and limited by the Constitution and Bylaws of this Corporation.

#### **ARTICLE IX: AMENDMENTS**

The Articles of Incorporation shall be amended or restated by the church Board of Elders at any time deemed necessary by them. All amendments and restatements require a unanimous vote. When an amendment or restatement is made, the Elders shall inform the congregation of those changes at the next church business meeting.

#### **ARTICLE X: DISSOLUTION**

Upon dissolution of this Corporation, any assets remaining after full payment of all debts and liabilities of this Corporation shall be distributed by the Board of Elders to another church,

missionary organization or religious ministry whose Statement of Faith and purposes are similar to that of this Corporation as expressed in its Constitution and Bylaws. Such distributions shall be made only to corporations which are organized and operated exclusively for religious purposes and which have established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
