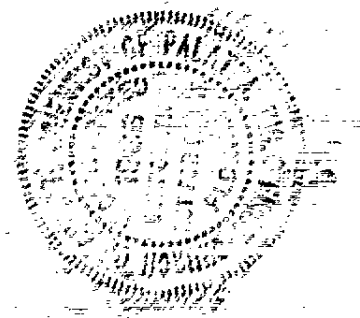
First Church Of Christ, Scientist Of Palatka, Inc., by vote of it's Membership is officially dissolved effective this First Day of July in the Year 2000.
