ARTICLES OF AMENDMENT

The following provisions of the Articles of Incorporation of **PLANNED PARENTHOOD ASSOCIATION OF SOUTHWEST FLORIDA, INC.**, a Florida not-for-profit corporation, filed with the Florida Secretary of State on May 24, 1966 (Document No. 710922), be and they hereby are amended in the following manner:

1. Article 1 be, and is hereby amended and revised in its entirety and made to read as follows:
The name of this corporation is **PLANNED PARENTHOOD OF SOUTHWEST AND CENTRAL FLORIDA, INC.** and its principal office shall be located at 1958 Prospect Street, Sarasota, FL 34239-2217, or such other place as may be designated by its Board of Directors from time to time.
2. The foregoing amendment was adopted at a meeting of the Board of Directors and members of the Corporation in accordance with Section 617.1002, Florida Statutes, on the 20th day of November, 1997. The number of votes cast for amendment was sufficient for approval.
