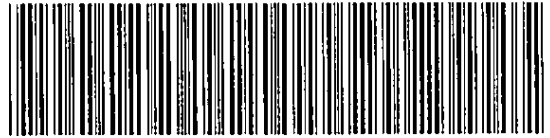

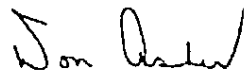

ARTICLES OF INCORPORATION

of

FLORIDA JAYCEES, INC.

ARTICLE I - NAME

The name of this corporation shall be FLORIDA JAYCEES, INC.

ARTICLE II - PURPOSES

The purpose of this corporation shall be to promote cooperation among civic organizations of young men in the State of Florida, to increase their efficiency; to develop and foster the growth of such organizations; provide facilities for intelligent participation of young men in the solution of civic, state, and national problems; to promote the educational development of its members and others; to secure cooperative action in advancing the common purpose of its members; and to bring about uniformity of opinion and concentration of action upon questions affecting the civic and commercial welfare of the state and union.

ARTICLE III - MEMBERSHIP

Each local Junior Chamber of Commerce or Jaycee Club organized as a corporation not for profit, or an association, or in any other manner, in any of the cities, towns, municipalities, counties or other subdivisions of the State of Florida, and which pay dues to this corporation, shall be members hereof, and each male individual member of good reputation, of an age of not less than twenty-one (21) years nor more than thirty-five (35) years, of such local Junior Chamber of Commerce or Jaycee Club shall be a member of this corporation without payment of further dues or other qualifications; said dues to be paid by said local organization in accordance with the By-Laws of this organization. Membership shall be divided into three (3) classes as follows: local clubs, individual members, including regular, associate, honorary and life, and sustaining members.

ARTICLE IV - TERM

This corporation shall have perpetual existence unless dissolved pursuant to the provisions of F.S. 617.05.

ARTICLE V - SUBSCRIBERS

The names and residences of the subscribers to the corporation's certificate of reincorporation under F.S. 617.013 are as follows:

ARTICLE VI - OFFICERS

The officers of this corporation shall be a president, the immediate past president, a secretary, the vice president from each of the several districts, an international director, the members of the board of directors of the United States Jaycees from the State of Florida, each of whom shall be elected at the State Convention, and a treasurer, chaplain, executive vice president, and a general legal counsel, who shall be appointed by the president, all of whom shall hold office until June 1, of the year following their election or appointment, or until their successor has been installed.

ARTICLE VII - NAMES OF OFFICERS

The names and addresses of the officers who are to manage the affairs of this corporation until their successors are elected or appointed and installed, are attached hereto as Exhibit "A".

ARTICLE VIII - MEMBERS OF EXECUTIVE COMMITTEE

The affairs of the corporation shall be managed by the officers specified in Article VII above, and named in the attached Exhibit "A". Such officers shall be members of the executive committee which shall manage the



affairs of the corporation and its members of the board of directors of the corporation, together with two members from each local club in good standing.

ARTICLE IX - BY-LAWS

The By-Laws of this corporation are to be made, altered or rescinded by a two-thirds (2/3rds) vote of the directors of this corporation present and voting at a meeting of the board of directors or by a two-thirds (2/3rds) vote of the qualified delegates present and voting at any duly called meeting of the corporation, provided a quorum is present.

ARTICLE X - AMENDMENTS TO ARTICLES OF INCORPORATION

Amendments to the articles of incorporation must be approved by a two-thirds (2/3rds) vote of the qualified delegates present and voting at a duly called regular or special membership meeting.
