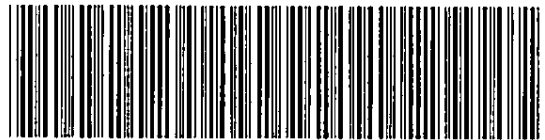

The undersigned, who with other persons are desirous of forming a corporation not for profit under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I. NAME

The name of this non-profit corporation is Iron Workers

Local No. 808 Building Company, Inc.

ARTICLE II. PURPOSES

The general nature of the objects and purposes of the corporation shall be to own, hold, maintain and operate a meeting place or places for its members and such other organizations as the corporation may from time to time allow to use such meeting place or places; to lease, rent, purchase, own or otherwise acquire and hold, furnish, equip, maintain and operate such club rooms, club houses or buildings, in such manner, and for such purposes and with such facilities as may be deemed necessary, desirable or expedient by the direction of the corporation; to purchase, own, hold, use, lease, let, mortgage, encumber, convey or sell such real or personal property as may be deemed proper, necessary or expedient in carrying out the purpose and object of the corporation; to erect, construct, build or contract for the erection, construction or building of club rooms, club houses or buildings for the use of the corporation and its members, as a meeting place or places, and for such purpose to make, execute and deliver all necessary instruments of conveyance, encumbrances or indebtedness, and to issue and sell its debenture

or mortgage bonds, secured by mortgage, trust deed, or other adequate security or otherwise to borrow or raise funds for the erection, construction, maintenance and operation of such buildings or club houses as the members of the corporation may desire; to contribute to such charitable or benevolent work as the members of the corporation may desire and determine; and, in general, to do any and all things which a natural person might or could do in the execution and furtherance of the purposes and objects of the corporation and for the use, benefit, comfort, convenience and enjoyment of its members.

The formation and existence of this non-profit corporation is for the object of permitting such non-profit corporation to receive and hold legal title to real property for the use and benefit of the members of the corporation who qualify for and achieve such status in accordance with the Articles of Incorporation.

ARTICLE III. QUALIFICATION OF MEMBERS

The qualifications of the members of this corporation shall be as follows:

(a) The membership of this corporation shall constitute all persons hereinafter named as subscribers and all other persons who are now in good standing in the present voluntary unincorporated association known as Local No. 808 affiliated with the International Association of Bridge, Structural and Ornamental Iron Workers, AFL-CIO and such other persons who, from time to time, become members of the aforesaid Local No. 808 and who comply with the by-laws of this corporation as they are adopted and may from time to time be amended.

(b) No member of the corporation, who shall cease to be a member as a result of either disciplinary action under the by-laws or

voluntary termination of membership, shall be deemed to have or have acquired, any right, claim or interest in or to any of the property of this corporation by virtue of his membership.

ARTICLE IV. TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE V. SUBSCRIBERS

The names and residences of the subscribers to these Articles of Incorporation who shall manage and conduct the affairs of the corporation as the interim Board of Directors until the first annual meeting or until their successors are elected and qualified in accordance with the By-laws are as follows:

ARTICLE VI. BOARD OF DIRECTORS

(a) The affairs of the corporation shall be conducted by a Board of Directors composed of fifteen members, from which there shall be elected a president, vice-president, recording and/or financial secretary and treasurer.

(b) The Board of Directors, under terms and conditions it prescribes, shall be authorized and empowered to designate and employ such personnel as the Board deems proper and essential to the achievement of the objects and purposes of the corporation.

(c) The directors of the corporation shall be elected by a vote of the members at a regular, annual meeting to be held on the first Tuesday after the first Monday in June of each year, pursuant to such other or further regulations governing such election as may be prescribed by the By-Laws.

(d) The Board of Directors shall hold a meeting immediately following each annual meeting of the members of the corporation and elect a Chairman of the Board. The Chairman of the Board shall not hold any other corporate office. Such Chairman and officers shall hold office for a term of two years or until their successors are elected and qualified.

ARTICLE VII. OFFICERS

The names of the officers who shall manage and conduct the affairs of the corporation, until the first annual meeting, or until their successors are elected and qualified, in accordance with the By-Laws, are as follows:

ARTICLE VIII. BY-LAWS

By-Laws of the corporation shall be adopted at a special meeting of the Board of Directors to be held as soon as practicable after the approval of this charter. The By-Laws must be adopted by a two-thirds vote of the full Board. Thereafter, the By-Laws may be altered, amended, added to, or rescinded only by vote of the membership, and such action shall be in accordance with the applicable provisions of the By-Laws as adopted.

ARTICLE IX. AMENDMENT

These Articles of Incorporation may be amended at a special meeting of the membership called for that specific purpose by the Board of Directors. A majority vote of the members present at such special meeting is required in order to effect amendment of these Articles.

ARTICLE X. LOCATION

This corporation shall be located at 1500 N. Goldenrod Road in the city of Orlando 32807, county of Orange, state of Florida, but the Board of Directors may change such location from time to time in the best interest of the corporation.

ARTICLE XI. GENERAL

- (a) No part of the net earnings of the corporation shall inure to the benefit of any individual or member.
- (b) The corporation may provide in its By-Laws for the holding of additional regular meetings and any special meetings, and shall provide notice of all such meetings.
- (c) Twenty-Five (25) members shall constitute a quorum for the holding of any meeting.

(d) Upon dissolution of this non-profit corporation, the assets of the corporation, if any there be, shall be distributed and disposed of in a manner consistent with the determination of a majority of the members present and voting in an election held for the specific purpose of determining the distribution of assets upon dissolution.

IN WITNESS WHEREOF, we, the undersigned subscribing incorporators, have hereunto set our hands and seals, this 11 day of July, 19 66, for the purpose of forming this corporation not for profit under laws of the State of Florida. The undersigned further acknowledge that they intend in good faith to carry out the objects and purposes set forth in these Articles of Incorporation.
