The undersigned non-profit corporation adopted the following Amendments to its Articles of Incorporation.

Excerpt from the minutes of a meeting of the Board of Directors and Active Members of the Delta Rho Chapter House Association, Inc. held at 11515 53rd Street North Clearwater, Florida 33760 (Stevens & Stevens Business Records Management, Inc.) on January 8, 2005.

After full discussion, during which it was pointed out that the present properties, including land and improvements, owned by the Housing Corporation at 1120 and 1130 SW 9th Road in the City of Gainesville, Florida are currently valued in excess of \$500,000. It was also pointed out that the construction of our new house on the same property will most likely result in a property with improvements valued at over \$4.5 million. It was discussed that a loan in excess of \$4 million may need to be taken out to pay for the construction of the new house. Construction is to begin in 2006.

Currently, Article IX states that the highest amount of indebtedness or liability to which this corporation may at any time subject itself shall be \$250,000.

It was moved by Director Marshall Stevens that the Articles of Incorporation be amended. The motion was seconded by Tom Santilli (Vice President) and unanimously approved to delete Amendment IX from the Articles of Incorporation. This will leave no debt limit for the corporation.

Currently, Article X states that the Delta Rho Chapter House Association, Inc. may hold real estate in the amount of value of \$500,000.

It was moved by Director Marshall Stevens that the Articles of Incorporation be amended. The motion was seconded by Tom Santilli (Vice President) and unanimously approved to delete Amendment X from the Articles of Incorporation. This will eliminate the \$500,000 limitation for holding real estate.
