Pursuant to the provisions of Section 617.1105 of the Florida Not For Profit Corporation Act, the undersigned corporations hereby execute these Articles of Merger for the purpose of merging two Florida not-for-profit corporations.

1. The plan of merger is as follows:
  - a. Barry University School of Law, Inc., a Florida not-for-profit corporation shall merge with and into Barry University, Inc., a Florida not-for-profit corporation.
  - b. Upon the merger, Barry University, Inc., shall be the surviving corporation. The articles of incorporation, as amended and bylaws, as amended of Barry University, Inc., shall continue in full force and effect after the merger.
2. The merger was approved by the sole member of Barry University School of Law, Inc. by a unanimous written consent action adopted as of June 8, 2000 and executed in accordance with Section 617.0701.
