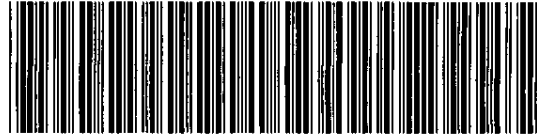

## **Articles Of Incorporation**

### **ARTICLE I Name**

This organization shall be known as the "FLORAHOME-GRANDIN VOLUNTEER FIRE DEPARTMENT, INC., a non-profit corporation.

### **ARTICLE II Principal Office**

Principal place of business: 201 W. Ohio St.  
Florahome, FL 32140

### **ARTICLE III Purpose**

#### **Section 1**

It's purpose shall be to prevent fires and to preserve life and property within the designated boundaries of Station 14 of Putnam County; and other areas such as dispatched by Putnam County Fire Control.

a) Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

b) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

### **Article IV Elections**

The Officers of this organization shall be elected biennially to take their offices on the first meeting night in April. The election, which shall be by ballot, shall be on the first meeting night in March. Nominations shall be on the first meeting night in February. The term of each office shall be for two (2) years. Election for President, Secretary, and Director I shall be held on odd years. Election for Vice-President, Treasurer, and Director II shall be held on even years. Director III shall be the outgoing president, unless he is unavailable, at which time Director III shall be elected by the membership.
