I am responding to your notice dated June 14, 2000 addressed to the YMCA of St. Lucie County, Inc. The YMCA of St. Lucie County, Inc. has since merged with the YMCA of Martin County and the surviving organization has been named the YMCA of the Treasure Coast.

Regarding the 1999 corporate annual report for the YMCA of St. Lucie County, Inc., the rejection from your office was not received by the personnel then in place. Per your instruction, I have included the 2000 UBR and check for \$61.25 hopeful that the St. Lucie County YMCA will be reinstated.

Anticipating reinstatement, the YMCA of Treasure Coast filed documents on May 25, 2000, with the Division of Corporations to 1) dissolve the YMCA of St. Lucie County, Inc. and 2) change the name of the surviving corporation. Those documents are currently waiting to be processed after the reinstatement. I request that you contact Louise from the Division of Corporations at (850) 487-6910. Louise is waiting for the reinstatement to be processed and the reinstatement fee to be paid. By contacting her on our behalf, you can greatly expedite the rest of the process for us.
