

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER(S) BEING AMENDED, ADDED OR DELETED.)

Whereas the required majority of the voting membership of the corporation at its Annual Business meeting held on the 23rd day of January 1999 have approved the amendment of Article III of the Articles of Incorporation to exclude the phrase "of the African race";

Resolved that Article III of the Articles of Incorporation be amended to read as follows;

Any person who believes in only one living and true God, an infinite, intelligent Spirit, the divinity of Jesus Christ, and that in the unity of the Godhead there are three persons, the Father, the Son, and the Holy Ghost equal in every divine perfection and baptism by immersion and the articles of faith set forth hereinabove may become a member of the church, or religious society upon being elected to membership by the Board of Directors.
