*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.*

**FIRST:** Amendment(s) adopted: (INDICATE ARTICLE NUMBER(S) BEING AMENDED, ADDED OR DELETED.)

Whereas the required majority of the voting membership of the corporation at its called business meeting held on the 9th day of June 1999 have approved the amendment of Article X paragraph one of the Articles of Incorporation to exclude the phrase "which shall not exceed the sum of \$25,000.00, provided, however, that such holdings shall always be subject to approval of the Circuit Judge of Broward County, Florida";

Resolved that Article X paragraph one of the Articles of Incorporation be amended to read as follows;

The corporation may own and hold real estate in any such amount as deemed necessary or appropriate by the corporation.
