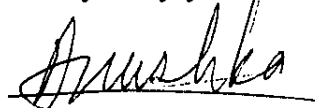

Pursuant to the provisions of section 617.1006 of the Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

ARTICLE I

The name of this corporation shall be COOPERATIVE LIVING ORGANIZATION, INC., AND ITS OFFICE AND PRINCIPAL PLACE OF BUSINESS SHALL BE LOCATED IN Gainesville, Alachua County, Florida, and such other place or places in the State of Florida as the directors shall from time to time designate.

After ten (10) days' notice, as provided in ARTICLE XI of the Charter, more than two-thirds of the active voting members voted to amend the Articles of Incorporation, as indicated on January 14th, 2009. This amendment shall be effective immediately.
