
I am writing regarding the reinstatement of the above-referenced Florida, not-for-profit corporation. It has just recently come to our attention that our corporation is no longer active in the State of Florida and we respectfully request that the Division of Corporations reinstate our corporation, and waive the reinstatement fee required for administratively dissolved corporations.

It appears that all Notices from your Division concerning annual fees and dissolution were sent to an incorrect address. They appear to have been sent to 2650 NW 46th Street, Boca Raton, FL 33434 and we had moved from that address several years ago to the above address. I have never received any Notices or Reports of fees due or Notices of any pending dissolution. It would be a tremendous financial hardship to our not-for-profit corporation to pay the reinstatement fee for administratively dissolved corporations.

Our completed current Uniform Business Report is attached, along with a check for \$192.50, for 3 years' of prior annual fees in the amount of \$183.75 and for a Certificate of Status in the amount of \$8.75.
