Per our telephone conversation, I have reviewed the records of the Cloverleaf 4-H Park of Christmas, Inc., and while I was unable to find documentation as to their 501(3)(c) I did find the following facts which I conclude establishes this corporation was and is in fact a 501(3)(c) Corporation as defined by the Internal Revenue Service:

- 1. The Cloverleaf 4-H Park of Christmas, Inc., was organized to provide educational programs for members of the 4-H boys and girls of Orange County, FL in the area of grazing, timber, recreation and other 4-H agricultural products. The programs continue to this day in cooperation with the Orange County Extension Service.
- 2. The property that Cloverleaf owns was donated to the organization and is currently tax exempt on the Orange County Tax Rolls.
- 3. The programs of the 4-H club receive donations from the public as well as Orange County.
