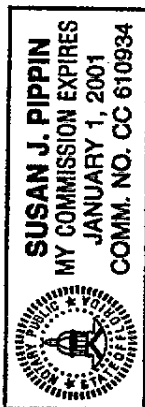

**General Assembly Business Meeting**  
**January 25<sup>th</sup>, 1999**

A church business meeting was held January 25<sup>th</sup>, 1999 in the church auditorium. The meeting was opened with prayer by Pastor David Myers. Pastor Myers then presented to the church the following resolution:

Be it resolved that **Article Three section 1** of the church by-laws be revised and amended to reflect the following sentence deleted. "At least three and not more than seven". **Article Three section 1** should than read as follows:

"The officers of the church shall be as follows: A Pastor, an assistant pastor when one is needed, deacons or members of a church board, at least three trustees when property is owned, and a secretary-treasurer."

A motion was made by Br Allyn Saunders to entertain the resolution and seconded by Br Patrick Sias. Following a discussion on the motion, the motion was voted upon and carried.


Pastor David Myers then proposed that changes in the Articles of Incorporation be made as follows:
