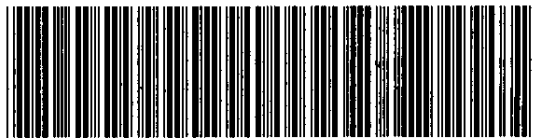



Thank you for your reply. I did submit the forms and Articles of Incorporation and on April 9, 2010 Tina Roberts, Regulatory Specialist II, sent them back to me on Letter # 210A00008718.

The "Woman's Club of Welaka, Inc. (Document # 712719 filed 5/10/1967) and the GFWC Woman's Club of Welaka, Inc. (document # N08000009107 filed 9/2008) are one and the same. The Articles of Incorporation are identical, the officers names, addresses and offices are identical and the mailing address and the phone numbers on both document numbers are identical. The name is correct on N08000009107 and all we want to do is add GFWC before the name on document # 712719.

I assumed the office of the treasurer on May 1, 2008. Our past President was working with a CPA to apply for a 501C3 status for our Womans Club. The CPA obviously searched for GFWC Welaka Woman's Club on sunbiz.org and when that name was not found, this application was submitted and the new corporation was assigned the N08000009107 document number. If you compare the information for the two document numbers you will see they represent the exact same club.

We are a charitable organization run by volunteers. \$70 of our fundraising funds were paid to your organization for an unnecessary duplicate corporation. The CPA filed for the new corporation and paid the \$70 and I wrote a check to pay them for this expense but did not realize it was creating another corporation. Now we are trying to spend another \$35 of our funds that should be going to a charity so we can hopefully get the name corrected to GFWC Welaka Woman's Club, Inc. and then proceed with filing our 501C3 application with our correct name.

Ms Roberts' letter states: the "name designed in your document is unavailable since it is the same as, or it is not distinguishable from the name of an administratively dissolved/revoked entity. Names of administratively dissolved/revoked entities are not available for one year from the date of administrative dissolution/revocation unless dissolved/revoked entity provides the Department of State with an affidavit or letter stating that they have no intention of reinstating, therefore, releasing the name for use to another entity."

Since the information is the same for both document numbers with the exception of GFWC in the title, wouldn't that information be sufficient for providing the requested information.

Do I need to send another e-mail to advise you that we have no intent of reinstating the name on document N08000009107? (We have no intent of reinstating the name on document N08000009107!!)

Please e-mail me what I need to do to have GFWC added to the original document # 712719 and make N08000009107 go away forever. Thank you for taking the time to read this lengthy e-mail. Remember we are volunteers and these funds total \$105 that were intended for chairties.
