ARTICLES OF AMENDMENT

Pursuant to Section 617.1006 and 617.01201 of Florida Statutes, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:

- 1. Article III is hereby amended to read as follows:
 - "The purpose for which this corporation is organized is exclusively religious, within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law.
 - "a. The general nature of the objectives of this corporation is to maintain and promote religious worship according to the general usages of the Baptist faith.
 - "b. Notwithstanding any other provision of these Articles, this organization shall not conduct any activities not permitted to be carried-on by an organization exempt from Federal Income tax under section 501 (c) (3) of the Internal Revenue Code of the Internal Revenue law."
- 2. The foregoing amendment was adopted on **December 1, 2008**, by a majority vote of those members present at a special meeting of the membership called for the amendment purpose aforesaid, pursuant to the provisions of Article IX of the Articles of Incorporation. The number of votes cast for the amendment was sufficient for approval.
