ARTICLES OF AMENDMENT

to

ARTICLES OF INCORPORATION

Article 1

- Section 1 The name of this corporation shall be St. Mary Missionary Baptist Church of North Miami Beach, Inc
- Section 2 The ^{principal} location of this church shall be 1550 N. E. 152nd Terrace, North Miami Beach, Florida 33162. It's corporate existence shall be perpetual.
- Section 3 This church shall subject to the rules of our Savior as outlined in the Holy Bible, Church Covenant, and By-Laws.
- Section 4 This church shall have a mission statement as stated below and shall be posted as so ordered by its trustees/directors.

Article 11

Mission Statement

The purpose of this Church is to carry on the Great Commission of Jesus Christ as recorded in the Holy Bible: to teach and to preach to all nationalities the Kingdom of God as demonstrated by the Life of Jesus Christ and to carry out the highest ideals of Christianity through various teaching mechanisms; not limited to the member only, but also to the overall community world wide, such as: Sunday School, Member Orientation, Bible Study, Personal Evangelism (Nurturing Baptist Churches (NBC) or Baptist Training Union (BTU).

Article 111

- Section 1 Membership can be obtained by Bible believing persons willing to believe the Word of God as is found in the Holy Bible and by Water Baptism (emersion), Christian Experience and or Letter, and Re-dedication.
- Section 2 Members shall be willing to submit to the Holy Spirit as a guide toward excellence in Christian growth and Christian conduct.
- Section 3 Demonstration of such willingness shall be visible through regular participation in Church activities and regular attendance of Church Worship.
- Section 4 Members shall support the Church through tithe and offering regularly. Each member is expected to contribute 10% of his/her net income per pay period and to give regularly in offerings as ordered by the Church Covenant. Each member is expected to contribute physical work towards the physical well being of the Church and in related cases may be in lieu of tithes if no other reported income is earned.
- Section 5 Any member may bequeath, as they will, any amount to this Church as the Holy Spirit dictates.

- Section 6 Each member will obey civil laws and be willing to be governed by the By-laws of this Church.

Article IV

OFFICERS

- Section 1 The officers of this Church shall be Pastor and Deacons
- Section 2 There shall also exist positions of office that shall not necessarily be officers of the Church, such as: trustee/Director, Recording Secretary, Financial Secretary, Treasurer (who shall be bondable), Church Minister of Music, Minister of Christian Education, Church Business Administrator, and Pastor's Secretary, or any other office appointed, or ordered by the general membership of the Church. Each officer is expected to abide by the tenets and regulations of the Church, to include tithing and or regular Church attendance and other related activities.
- Section 3 Any officer or auxiliary officer in excess of 3 consecutive meetings of regularly scheduled meetings without reasonable excuse shall be void of that office and subject to the Board of Deacons and Pastor for reinstatement. The decision shall be non-negotiable and binding by 2/3 majority of members present.
- Section 4 The governing body of this Church shall consist of Pastor, Board of Deacons, and Board of Trustee/Directors which shall meet on a quarterly basis to discuss the financial focus of the Church and provide fundraisers to support the Church.
- Section 5 The Board of Deacons shall also be empowered to review the stewardship of any member's conduct that brings God to an open shame or if any member becomes remiss in his/her responsibilities and duties to the Church. The Deacons shall also first make recommendations for correction and consequent sanctions as ordered by the by-laws of the Church.

Article V

INVESTITURE DISCLOSURE

No member of the Church shall have any individual or personal rights, title Or interest in any property, real or personal, belonging to the Church. Any rights, Title or interest that may exist in any member, shall cease upon termination of his/ Her membership. Any property existing upon dissolution of the Church shall upon Vote cast in a manner provided in the by-laws hereinafter enacted, be given to Some worthy non-profit organization.
