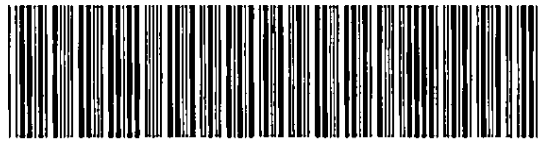



Pursuant to the provisions of Section 617.1007, Florida Statutes, FLORIDA INSTITUTE OF CERTIFIED PUBLIC ACCOUNTANTS EDUCATIONAL FOUNDATION, INC. adopts the following Amendment to its Restated Articles of Incorporation.
