#### PETITION FOR APPROVAL OF ARTICLES OF MERGER

Petitioner, Montverde Academy, Inc., a Private School, a not for profit corporation, by and through its undersigned counsel, alleges:

- 1. This is an action for court approval of Articles of Merger for a private school organized under the Private School Corporation law of 1959, Chapter 623, Florida Statutes.
  - 2. This Court has subject matter jurisdiction under Chapter 623, Florida Statutes.
- 3. This Court has personal jurisdiction because Petitioner's principal place of business is in Lake County Florida.
  - 4. The facts upon which Petitioner relies are as follows:
- (a) Petitioner, "Montverde Academy, Inc., a Private School., was formed under Chapter 623 of Florida Statutes by Order of this Court dated February 22, 1988, a copy of which is attached as Exhibit A, which was recorded in O.R. Book 954, Page 549 of the Official Records of Lake County, Florida.
- (b) The Trustees of Petitioner have unanimously agreed and resolved that it is in the best interest of the Corporation to be incorporated under Florida Statutes Chapter 617, rather than Florida Chapter 623, because Chapter 617, Florida Statutes, is more conducive to the activities and purposes of the Corporation.
- (c) Legal counsel has advised the Board of Trustees and recommended the merger of the Corporation into Montverde Academy. Inc., a Florida Corporation, which is incorporated under Florida Statutes Section Chapter 617, duly filed with the Department of State of the State of Florida (document number 71335), and which corporation is identical in its operations and functions to Petitioner. Montverde Academy, Inc., a Florida Corporation (document number 71335) is also a public charity under Section 501(c)(3) of the Internal Revenue

Code of 1986, and it has received a letter from the Internal Revenue Service confirming its tax exemption under Section 501(c)(3) of the Internal Revenue Code of 1986.

- (d) The Board of Trustees has unanimously approved the Agreement and a Plan of Merger at a duly called and properly noticed meeting held on February 12, 2020, at Montverde Academy, 17235–7th Street, Montverde, FL 34756, and each of the Trustees executed the Agreement and Plan of Merger. A copy of the Agreement and Plan of Merger are attached hereto.
- (e) Pursuant to the Agreement and Plan of Merger, Petitioner will merge into Montverde Academy, Inc., a Florida corporation (document number 71335), and Montverde Academy, Inc., a Florida corporation, will be the surviving entity and will succeed to all the assets and liabilities of Petitioner.
- (f) Petitioner has no members, so membership approval of the Plan of Merger or Articles of Merger is not necessary.
- (g) The Agreement and Plan of Merger was duly filed with the Clerk of the Circuit Court in Lake County, Florida, on March 4, 2020, in accordance with Florida Statutes Section 623.07 and 623.14.
- 5. This Court has the jurisdiction to approve the merger under Florida Statutes Section 623.07 and Florida Statute Section 623.14. Florida Statute Section 623.07 authorizes the merger of two corporations formed under Chapter 623, and Florida Statute Section 623.14 provides that the powers and authority granted to corporations under Florida Chapter 617 are supplemental to those under Florida Statutes Chapter 623. See *State v. Palm Beach County*, 575 So2d. 652 (1991). Florida Statutes Chapter 617.1102 expressly authorizes the merger of corporations formed under Chapter 617. Florida Statutes, with "other eligible entities... as defined in Florida Statutes Section 607.1101(1), which include Petitioner. See F.S. 607.01401(28)(a)8 ("Eligible entity," includes any domestic entity organized under organic law), and F.S. 607.01401(53) ("Organic law, means the laws of the jurisdiction in which the entity was formed).

WHEREFORE. Petitioner asks this Court to approve the Agreement and Plan of Merger.

#### AGREEMENT OF MERGER

This AGREEMENT OF MERGER (the "Agreement") is made and entered into this 12th day of February, 2020, by and between Montverde Academy, Inc., a Private School, which is a corporation organized under Chapter 623 of Florida Statutes ("Montverde Private School,), and Montverde Academy, Inc., a corporation organized under Chapter 617 of Florida Statutes ("Montverde Academy,).

#### RECITALS

**WHEREAS**. Montverde Private School and Montverde Academy both operate under the authority of and are managed by a single Board of Trustees:

WHEREAS, neither Montverde Private School nor Montverde Academy has any members;

WHEREAS, the Internal Revenue Service has issued an opinion letter to Montverde Academy stating that Montverde Academy is a charitable organization within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, and Montverde Academy has maintained and continues to maintain that status as a charitable organization under Section 501(c)(3) of the Internal Revenue Code of 1986.

WHEREAS, the Board of Trustees of both Montverde Private School and Montverde Academy has determined that it is in the best interest of the corporations to merge them and operate under a single corporate structure under Florida Statutes Chapter 617:

WHEREAS, the Board of Trustees, on behalf of each of Montverde Private School and Montverde Academy, hereby enter into this Merger Agreement to merge Montverde Private School into Montverde Academy, whereupon Montverde Private School shall cease to exist and Montverde Academy shall be the sole surviving corporation:

**NOW, THEREFORE**, for and in consideration of the covenants, terms, and agreements set forth herein, and other good and valuable consideration, the receipt, adequacy, and sufficiency of which are hereby expressly acknowledged by the parties hereto, the Board of Trustees, on behalf of each of Montverde Private School and Montverde Academy, hereby covenant and agree as follows:

1. Recitals. The above Recitals are true and correct, are material to the undertakings under this Agreement, and are hereby incorporated into this Agreement by reference.

#### 2. <u>Approval of Merger</u>.

(a) Subject to the terms and conditions of this Agreement, the Board of Trustees, on behalf of each of Montverde Private School and Montverde Academy, approves, authorizes and directs the merger of Monteverde Private School into Montverde Academy.

(b) The Board of Trustees, on behalf of Montverde Private School and Montverde Academy, approve and adopt this Agreement of Merger and all Exhibits thereto, including the Plan of Merger and the Articles of Merger.

- (c) The Board of Trustees, on behalf of each of Montverde Private School and Montverde Academy, acknowledge the effect of the merger under Chapter 617, Florida Statutes, specifically that, upon the merger becoming effective:
  - (1) The separate existence of Montverde Private School shall cease:
- (2) The title to all real estate and other property or any interest therein owned by Montverde Private School shall be vested in Montverde Academy, without reversion or impairment:
- (3) Montverde Academy shall be responsible and liable for all the liabilities and obligations of Montverde Private School:
- (4) Any claim existing or action or proceeding pending by or against Montverde Private School may be continued as if the merger did not occur or Montverde Academy may be substituted in the proceeding for Montverde Private School:
- (5) Neither the rights of creditors nor any liens upon the property of Montverde Private School shall be impaired by such merger:
- (6) The amended and restated articles of incorporation and bylaws of Montverde Academy shall govern the formation and internal affairs of Montverde Academy, subject to future amendments as otherwise provided for therein; and
- (7) The assets of Montverde Private School will be dedicated to the charitable purposes of Montverde Academy. Inc., which is a public charity under Section 501(c)(3) of the Internal Revenue Code of 1986.
- 3. <u>Authorization and Delegation of Authority</u>. The Board of Trustees hereby authorizes and delegates to the Chairwoman of the Board of Trustees the authority to execute all documents and take such other action as is required, appropriate or helpful to implement this Agreement of Merger, including any amendment to the Plan of Merger or the Articles of Merger that may be necessary or helpful to facilitate the filing, implementation and effectuation of the merger. The Chairwoman is further authorized to take any and all actions necessary, appropriate or helpful under Chapter 623, Florida Statutes, to secure the approval of the merger by the Fifth Judicial Circuit Court of Florida in and for Lake County, Florida.
- 4. Representations and Warranties of Trustees. The Trustees represent and warrant as follows:

The Parties herein agree to submit any dispute with regard to or related to this Agreement or the performance thereof or the obligation therein to the personal jurisdiction and exclusive venue of the Fifth Circuit Court in and for Lake County, Florida or the County Court for Lake County, Florida. This provision shall survive Closing.
- 7. <u>Counterparts.</u> This Agreement may be executed in any number of counterparts and all so executed counterparts shall constitute one Agreement, which shall be binding upon all Parties hereto, notwithstanding that all Parties' signatures do not appear on the same page, and the Parties further agree that a photocopy, facsimile copy, or other reproduction of this Agreement shall be as binding and effective as the original.
- 8. <u>Effective Date</u>. The Effective Date of this Agreement of Merger shall be the date on which it is executed by the Trustees.
