ARTICLE IX AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

- 2. A resolution approving a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meetings considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary at or prior to the meeting. Except as elsewhere provided,
 - (a) such approvals must be by not less than 75% of the entire membership of the Board of Directors and by not less than 60% a majority of the votes of the entire membership of the Association.; or
 - (b) by-not-less-than-80% of the votes-of the entire-membership of the Association.
