

ARTICLES OF INCORPORATION OF FIRST METHODIST CHURCH OF LAKE ALFRED, INC.

We, the unlersigned, hereby associate ourselves together for the purpose of becoming incorporated under the provisions of Chapter 617, Florida Statutes 1965, applicable to coporations not for profit, accepting all the rights, privileges, benefits and obligations conferred and imposed by said law, and we do hereby make, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation shall be First Methodist Church of Lake Alfred, Inc., whose Street address is 260 West Haines Boulevard, Lake Alfred, Florida, and whose mailing address is P. O. Box 1227, Lake Alfred, Florida, 33850.

ARTICLE II - OBJECT

The general nature, objects and purposes for which this Corporation is formed are:

- A. To acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, incumber, sell, convey and dispose of all such property in conformity with the Discipline of the Methodist Church.
- B. To promote in every possible way the purpose and objectives of the Methodist Church and to support its doctrine; and the Corporation and all or its property, both real and personal, shall be subject to the laws, usages and ministerial appointments of the Methodist Church as are now and shall be from time to time established, made, and declared by the lawful authority of the said Church.
- which individuals may direct and develop in the direction of the Highest Good; and to encourage, stimulate and provide a strong educational influence in the home and community.

D. Subject to the provisions of the Discipline, the Corporation shall have the power to creek and maintain buildings for the worship of God, for training in Christian faith and conduct, and for Christian social intercourse, and to acquire or build and maintain residences for the use and occupancy of its ministers.

E. If, for any reason, the Corporation shall cease to exist as a legal entity and its charter shall expire or be terminated, the title to all its property, both real and persor-1, shall be vested in the trustees of the Annual Conference, if the Annual Conference itself is unincorporated, in the same manner as it holds title to any other real estate, or in the Annual Conference in its corporate name if it is incorporated; and all such property shall be held in trust for the benefit of the local Church.

ARTICLE III - MEMBERSHIP

The membership of this Corporation shall be composed of the membership of the First Methodist Church of Lake Alfred including the Official Board and the Quarterly Conference of the First Methodist Church of Lake Alfred, or such other body of said Church.

ARTICLE IV - TERM

This Corporation shall have perpetual existence unless dissolved in accordance with the Statutes and Laws of the State of Florida.

Section 3. The officers shall be elected at the annual meeting of the Official Board, or as provided in the by-laws.

ARTICLE VII - BOARD OF DIRECTORS

The business affairs of this Corporation shall be managed by the Official Board, and Trustees of the First Methodist Church of Lake Alfred.

This Corporation shall have not less than three Directors initially.

The number of Directors may be increased from time to time by the by-laws, but shall never be less than three.

ARTICLE VII - BY-LAWS

Section 1. These Articles of Incorporation may be amended at a special meeting of the membership called for that purpose, by a threefourth vote of those present.

Section 2. Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the by-laws, or intention to submit such amendments.

ARTICLE X - LOCATION

The location of this corporation shall be at 260 West Haines Boulevard in the city of Lake Alfred, County of Polk, State of Florida.
