RE: Amendment to Articles of Incorporation

The Homosassa Civic Club, Inc. intends to file for a 501(c)(3) status. In order to continue to work within the federal guidelines for 501(c)(3) charitable organizations it was necessary to make three (3) changes to our Articles of Incorporation.

We held a duly recorded meeting, as called for in our Articles of Incorporation, and the members voted to accept the changes.

Change #1: The word "philanthropic" was deleted from the preamble. This was recommended by the federal guidelines because there is no legal definition of philanthropic operations.

The preamble now reads:

"We, the undersigned, with other persons being desirous of forming a corporation for charitable purposes, under the provisions of Ch. 617 of the Florida Statutes, do agree to the following:"

Change #2: We added the following sentence to Article II. "The Homosassa Civic Club, Inc. will operate for charitable purposes as permitted by section 501(c)(3) of the Internal Revenue Code of the United States".

Article II now reads:

The general nature of the objects and purposes of this corporation shall be: The promotion and advancement of the civic development of Homosassa, Florida, but all activities of the corporation shall be non-partisan and nonsectarian and the corporation shall not, by resolution or otherwise, commit itself or its membership to the support or endorsement of any candidate for public office. The Homosassa Civic Club, Inc. will operate for charitable purposes as permitted by section 501(c)(3) of the Internal Revenue Code of the United States."

Change #3: We added the following Article:

Article XI. Dissolution

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose."
