

AMENDED AND RESTATED ARTICLES OF INCORPORATION

BY THESE AMENDED AND RESTATED ARTICLES the incorporator forms a corporation under the Florida Not For Profit Corporation Act.

- i. NAME. The name of this corporation is BETHEL CHURCH, INC
- PRINCIPAL OFFICE. The address of the principal office of this corporation is 238 S. Osprey Ave., Sarasota, FL 34236 and its mailing address is the same.

3. PURPOSES.

- (a) The purposes for which this corporation is organized are for a church and related religious as well as educational purposes.
- Notwithstanding any other provision of these articles, this corporation? shall not carry on any activities not permitted to be carried on by a non-profit organization.
- This corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, efficers of other private persons, except as reasonable compensation for services rendered or to pay and distribute assets in furtherance of the purposes specified in this article. (A)
- On dissolution of this corporation, the assets of the corporation tiall be distributed for one or more charitable and/or religious, non-profit purposes. Any assertant share disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of the corporation is then located exclusively for such purposes.
- BOARD OF DIRECTORS. The method of selecting directors of this corporation shall be stated in the bylaws. This corporation shall have five directors initially. The number of directors may be changed from time to time in the bylaws so long as the number is not less than three. The name and address of each person who is to serve as an initial director is:
