The terms and conditions of the merger are as follows:

These two local congregations of the Florida Conference of the United Methodist Church have joined together for the purpose of continuing our mission of making disciples for Jesus, serving the needs of our membership, and serving the needs of the communities we serve through our primary location (campus) in Miami Lakes, FL and our secondary location (campus) in Hialeah, FL. The Florida Conference of the United Methodist Church now recognizes these two congregations as one, with one Pastor offering direct worship services at the Miami Lakes location and facilitating the opportunity for other groups to worship at the Hialeah location. Pre-school and kindergarten education and childcare will continue to be offered at both locations. All contributions and donations will be made to the Miami Lakes United Methodist Church and all expenses for the newly merged entity will be satisfied by the Miami Lakes United Methodist Church for both locations.

A statement of any changes in the Articles of Incorporation of the surviving corporation:

The mission will continue to be the same, now executed through two physical locations, 14800 NW 67th Avenue, Miami Lakes, FL 33014, and 5700 West 12th Avenue, Hialeah, FL 33012. An updated Articles of Incorporation is attached.

Other provisions relating to the merger are as follows:

Property ownership of 5700 West 12th Avenue, Hialeah, FL 33012 and all other assets and liabilities of Palm Springs United Methodist Church, Inc are transferred to Miami Lakes United Methodist Church, Incorporated.
