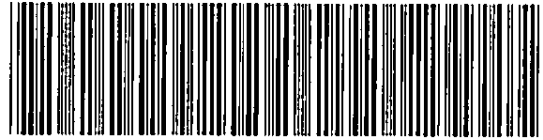

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, and respectfully petition the Secretary of State for approval of such corporation under the following proposed Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be the CHURCH OF CHRIST WRITTEN IN HEAVEN, OF MIAMI, INC., Florida, and its principal place of business and place of worship shall be at 324 N. W. 16th. Street, Miami, Dade County, Florida.

ARTICLE II

PURPOSE

The general purposes and objects of this corporation shall be to conduct for religious worship and instruction, churches, schools, and other institutions connected therewith of a religious, educational, charitable, and benevolent character to the end that its own members and others may be generally instructed and guided concerning its articles of faith; and to advance spiritual growth and enlightenment toward their personal purity among its own membership and the people of the community in which it is located, and for the purpose of promoting the foregoing objects, this corporation shall have the right to acquire, either by gift or purchase, and to hold, or, sell, mortgage, or encumber in any manner, lease and improve real estate and personal property for itself and others, either as Trustee or otherwise.

USE OF INCOME

All revenue, profit, income and money received from the conduction of such business or enterprise is to be used and employed in religious, educational, charitable, benevolent work and not for the benefit of the members of said corporation, either individually or collectively.

ARTICLE IV

POWERS

Said corporation is to have the power to do any and all things necessary or expedient for carrying out the said objects and purposes of the corporation and in general to possess all rights, privileges and immunities, and enjoy all the benefits granted to corporations of a similar character under the laws of the State of Florida.

ARTICLE V

QUALIFICATIONS FOR MEMBERSHIP

Every person who believes in repentance toward God, and faith in Jesus Christ, as Saviour and Lord, and will observe the Ordinances of Christ and be governed by His Laws, is qualified and eligible for membership in this corporation.

ARTICLE VI

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VII

BOARD OF TRUSTEES

1. The Business affairs of this corporation shall be managed by a Board of Trustees, subject to and in accordance with the By-Laws of the Church, of not less than six (6) members.

2. The Board of Trustees shall be elected from and by the membership of said Church Corporation in accordance with the By-Laws.

3. The present Board of Trustees of the CHURCH OF CHRIST WRITTEN IN HEAVEN, OF MIAMI, INC., not incorporated, and whose names are set forth herein, shall constitute the Board of Trustees and shall hold office until their successors are elected and in accordance with their present terms, to wit:

ARTICLE IX

BY-LAWS

ARTICLE X
