AMENDMENTS TO ARTICLES OF INCORPORATION OF GULF PINES ASSOCIATES, INC.



Article IV is hereby amended to read as follows:

Under the terms and conditions prescribed by its By Laws, this corporation shall admit as members only such persons as are homeowners, whither resident or non-resident, in the Gulf Pines Subdivision. Walton County, Florida, having a reasonable accessibility to the courses of, and who are in need of having water, sewerage and other services supplied for domestic, fire protection and garden purposes from the water system constructed, maintained and operated by the corporation, and who receives the approval of the Board of Directors upon subscribing for or otherwise acquiring a membership certificate and by signing such agreements for the purchase of water as may be provided and required by the corporation; (provided that no person otherwise eligible shall be permitted to subscribe for or acquire a membership of the corporation if the capacity of the corporation's water system is exhausted by needs of its existing members). A homeowner shall not be entitled to more than one membership certificate regardless of the number of homes he may own in Gulf Pines Subdivision and each certificate shall entitled to one vote regardless of whether the certificate is issued in the name of more than one person. All record owners of property in Gulf Pines Subdivision shall be members of the corporation.

Article IX, Section 2 is hereby amended to read as follows:

2. Each <u>lot certificates</u> shall be entitled to one vote <u>only and tThere</u> shall be no voting by proxy except by a signed written proxy authorizing approval or disapproval of the specific matter to be voted upon and designating the name <u>or office</u> of the proxy who shall cast such vote.

Article X, Section 2 is hereby amended to read as follows:

2. Each eertificate lot shall be entitled to one vote enly.
