ARTICLES OF AMENDMENT TO
ARTICLES OF MIAMI SHORES CHURCH OF CHRIST, INC.

The undersigned, being the minister and treasurer of MIAMI SHORES CHURCH OF CHRIST, INC., a corporation not-for-profit (the "Corporation"), for purposes of amending the Articles of Incorporation, pursuant to Florida Statutes Section 617.1006, so as to change the name of the Corporation, does hereby certify as follows:


1. The name of the Corporation is MIAMI SHORES CHURCH OF CHRIST, INC.
2. The Certificate of Incorporation of the Corporation is hereby amended by deleting Article I thereof in its entirety and by substituting in lieu thereof the following new Article I:

"ARTICLE I

The name of the Corporation shall be:
THE CHURCH OF CHRIST IN PERRINE, INC"

3. At a meeting of the members of the Corporation held on November 16, 1998 a sufficient number of votes were cast by the members to adopt this Amendment.

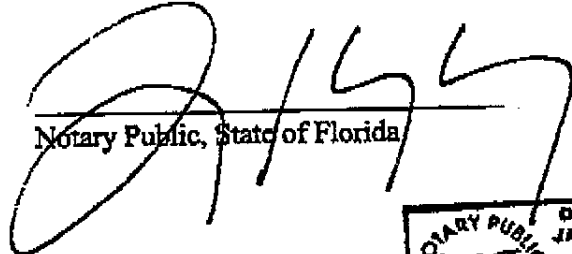

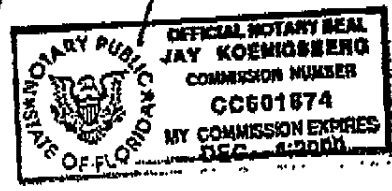
