

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TOWER VALLANDRY OF IBIS ISLE ASSOCIATION, INC.

THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TOWER VALLANDRY OF IBIS ISLE ASSOCIATION, INC. are made by TOWER VALLANDRY OF IBIS ISLE ASSOCIATION, INC. ("Association").

WITNESSETH:

WHEREAS, the Articles of Incorporation of the Association were originally filed with the Florida Secretary of State on June 24, 1968 (Document Number 714824).

NOW, THEREFORE, the President and Secretary of the Association hereby certify that:

- 1. The Amendment to the Articles of Incorporation set forth below has been properly and duly approved and adopted by the Association on December 14, 2020 pursuant to the provisions of the Articles of Incorporation. The number of votes cast by Association members in favor of the Amendment is sufficient for approval. Further, the below Amendment has been properly and duly approved by the Board of Directors.
- 2. Article V, Section A of the Articles of Incorporation is amended to read, as follows:

[Added language is <u>underlined</u>. Deleted language is stricken through.]

- "A. The affairs of the Association shall be managed by a Board of Directors consisting of a number of Directors determined by the Bylaws, but shall be not less than three. In the absence of such determination, the Board shall consist of three Directors.
 - "1. A Director must be a member of the Association, or a duly appointed representative of a member of the Association.
 - "2. Only One (1) person from or associated with any One (1) particular Unit may serve on the Board at any time.

Directors need not be members of the Association."

3. Article V of the Articles of Incorporation is amended by the addition of a new Section E which shall read, as follows:

"E. The representative director to represent the Association on the Ibis Central of Ibis Isle Association, Inc. Board of Directors will be elected annually by written vote cast by the majority of the Board of Directors of the Tower Vallandry Association."
