Pursuant to Chapter 617, *Florida Statutes* (2010), of the Florida Not for Profit Corporation Act, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. That the name of the Corporation is SPACE COAST ASSOCIATION OF REALTORS, INC. (hereinafter "Corporation", which reference includes modifications thereto).

2. That the following amendment of the Articles of Incorporation of the Space Coast Association of Realtors, Inc., was adopted at a meeting of the membership held on the 4th day of March, 2011, at which meeting a quorum was present and the Amendment received at least a majority of the votes that members present or represented by proxy at the meeting were entitled to vote, or by a majority ballot vote, or by a combination thereof, in accordance with the provisions of Article X of the Articles of Incorporation of the Space Coast Association of Realtors, Inc.

a. Article I of the Articles of Incorporation is deleted in its entirety and the following substituted therefor:

ARTICLE 1 - NAME- The name of the corporation shall be SPACE COAST REALTORS, INC.

3. The effective date of this Amendment to the Articles of Incorporation, will be as of the date of filing of these Articles of Amendment to the Articles of Incorporation with the Secretary of State for the State of Florida.
