AMENDMENT TO ARTICLES OF INCORPORATION OF BAYWOOD ON THE GULF, INC. (FORMERLY BAYWOOD ON THE GULF, INC., NO. 1)

The following is an amendment to the Articles of Incorporation of Baywood on the Gulf, Inc., formerly known as Baywood on the Gulf, Inc., No. 1, a Condominium, originally recorded at Official Records Book 2858, Page 580, et. seq. of the Public Records of Pinellas County, Florida, and as amended.

New Wording <u>Underlined</u>; Deleted Wording <u>Stricken Through</u> (Except when proposed amendment involves substantial rewording).

Article VIII of the Articles of Incorporation is amended to read as follows:

The By-Laws of the corporation are to be made, altered or rescinded by a three-fourths (3/4) two-thirds (2/3) vote of the members of this Corporation.
