ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
WINN-DIXIE FOUNDATION, INC.

Pursuant to the authority and provisions of Section 617.0821 of the Florida Not For Profit Corporation Act, Winn-Dixie Foundation, Inc. (the "Foundation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Foundation is Winn-Dixie Foundation, Inc.

SECOND: Article One of the Articles of Incorporation of Winn-Dixie Foundation, Inc. is hereby amended in its entirety to read as follows:

ARTICLE I
NAME OF CORPORATION


The name of this not-for-profit corporation shall be the BI-LO/Winn-Dixie Foundation, Inc. (the "Foundation").

THIRD: The amendment(s) was adopted by the sole member of the Foundation.

FOURTH: This amendment shall be effective on as of the date of filing with Office of the Secretary of State of the State of Florida.
