Pursuant to the authority and provisions of Section 617.0821 of the Florida Not For Profit Corporation Act, BI-LO/Winn-Dixie Foundation, Inc. (the "Foundation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Foundation is BI-LO/Winn-Dixie Foundation, Inc.

SECOND: Article One of the Articles of Incorporation of BI-LO/Winn-Dixie Foundation, Inc. is hereby amended in its entirety to read as follows:

NAME OF CORPORATION

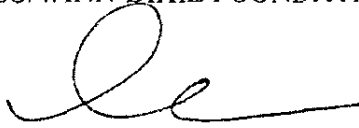
The name of this not-for-profit corporation shall be Bi-Lo Holdings Foundation, Inc. (the "Foundation").
