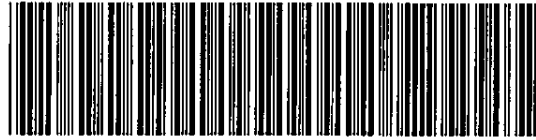

Amendment Adopted:

ARTICLE XI - Relationship to National Organization

Section 1: Florida Gulf Coast Paralyzed Veterans of America, recognizes The National Organization, Known As the Paralyzed Veterans of America, chartered by the US Congress, and affirms its allegiance as a subsidiary of the national Organization, It's Chapter, Bylaws and All Rules, mandates and regulations promulgated thereto.

Section 2: Florida Gulf Coast Paralyzed Veterans of America, shall perform the duties and obligations set forth in the Paralyzed Veterans of America Bylaws, Administrative Guide and Chapter Administrative Manual or other such duties and obligations as the PVA Executive Committee or Board Of Directors may, from time to time, require.

Section 3: Florida Gulf Coast Paralyzed Veterans of America, shall not amend its Articles of Incorporation unless it receives prior written approval of the PVA Executive Committee.

Section 4: Florida Gulf Coast Paralyzed Veterans of America, shall dissolve whenever the corporation's Charter is surrendered to or revoked by the Paralyzed Veterans of America.

Section 5: In the event of dissolution of Florida Gulf Coast Paralyzed Veterans of America, for any reason, any assets and property remaining after compliance with applicable provisions Of State Law shall be distributed to the Paralyzed Veterans of America.

The date of adoption of the amendment was: January 18, 2007

Effective Date: shall be on the Board Of Directors approval and filing with the State of Florida.
