



#### Articles of Incorporation

The Legal Aid Foundation of the Tallahassee Bar Association, Inc.

Pursuant to the provisions of Section 617.1006, Florida Statutes (2015), The Legal Aid Foundation of the Tallahassee Bar Association, Inc., a Florida Not For Profit Corporation, (the "corporation") adopts the following amendment to its Articles of Corporation:

1. Article II of the Articles of Incorporation is hereby amended to read in its entirety as follows:

## ARTICLE II OBJECTIVES

The purposes for which the corporation is organized are:

To provide legal services to all residents of Leon County, or nonresidents having cases pending in Leon County, appearing worthy of such aid, who shall be unable to procure legal assistance elsewhere.

2. Article III of the Articles of Incorporation is hereby amended to read in its entirety as follows:

#### ARTICLE III

#### **MEMBERSHIP**

Pursuant to the provisions of Section 617.0601(1)(a), Florida Statutes (2015), the corporation shall have no members.

3. Article VI of the Articles of Incorporation is hereby amended to read in its entirety as follows:

#### ARTICLE VI

#### **DIRECTORS**

The affairs and business of the corporation shall be managed by a board of directors of not less than three nor more than seventeen directors.

Directors shall be elected in the manner provided in the by-laws of the corporation.

4. Article VII of the Articles of Incorporation is hereby amended to read in its entirety as follows:

#### ARTICLE VII

#### **OFFICERS**

The officers of the corporation shall be elected in the manner provided in the by-laws and shall have such powers and duties as shall be set forth in the by-laws. The president of the corporation shall at all times be a member of the Tallahassee Bar Association.

5. Article X is hereby amended to read in its entirety as follows:

#### ARTICLE X

#### **POWERS**

The powers of the corporation shall be those powers enumerated in the Florida Not For Profit Corporation Act, as they may be from time to time amended.

6. In all other respects, the Articles of Incorporation dated November 27, 1968, as amended on July 8, 1986, are hereby ratified and confirmed.

This amendment to the articles of incorporation of The Legal Aid Foundation of the Tallahassee Bar Association, Inc. was approved and adopted by the board of directors of the corporation on January 26, 2016.
