AMENDMENTS TO THE ARTICLES OF INCORPORATION OF RIVERSIDE TERRACE CONDOMINIUM

Note: Additions are noticed by <u>underlines</u>. Deletions are notated by a hyphened strikethrough.

Article III(2)(e) of the Articles of Incorporation is hereby amended as follows:

ARTICLE III POWERS

The powers of the Association shall include and be governed by the following provisions:

- 2. The Association shall have all of the powers reasonably necessary to implement the purposes of the Association, including but not limited to the following:
 - (e) To make and amend reasonable regulations respecting the use of the property in the condominium; provided, however, that all such regulations and amendments thereto shall may be approved by the Board of Directors, but may overruled by a majority vote be approved by not less than 75% of the votes of the entire membership of the Association, before such shall become effective

Article IX(2) of the Articles of Incorporation is hereby amended as follows:

ARTICLE IX AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

2. A resolution approving a proposed amendment may be proposed by either the Board of Directors or by the membership of the Association, and after being proposed and approved by one of such bodies it must be approved by the other. Such approvals must be by all-of a majority of the directors and by not less than 75% a majority of the members of the Association. Directors and members not present at the meetings considering the amendment may express their approval in writing.
