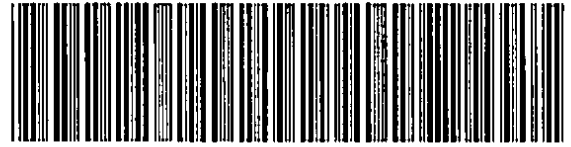



ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
RIDGEVIEW TOWERS, INC.

The undersigned officers of **Ridgeview Towers, Inc.** do hereby certify that the following amendments to the Articles of Incorporation of said corporation are a true and correct copy as amended, pursuant to Article IX thereof, by the membership at a duly called and noticed meeting of the members held February 20, 2020. The amendments were adopted by the members and the number of votes cast for the amendments was sufficient for approval.

CHANGES TO SECTION 1 OF ARTICLE IX OF THE ARTICLES OF INCORPORATION:

The Articles of Incorporation may be amended by the members at a duly constituted meeting for such purpose, provided, however, that no amendment shall take effect unless approved by a majority of the of the Board of Directors and by members representing at least ~~seventy-five (75%) per cent~~ sixty percent (60%) of the votes in the condominium, as set forth in the Declaration of Condominium. Notice of the subject matter of any proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.




