Pursuant to the provisions of Section 617.1002, Florida Statutes, F.E. Lykes Foundation, Inc. a Florida nonprofit corporation (the "Corporation"), has adopted the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is the F.E. Lykes Foundation, Inc.

SECOND: Amendment Adopted: the following paragraph is hereby added to the beginning of Article II of the Corporation's Articles of Incorporation:
