Articles of Incorporation Lake Ellen Christian Church

A Corporation Not For Profit

We, the undersigned, with other persons, being desirous of forming a corporation for charitable, religious and philanthropic purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

Article I - Name

The name of this corporation is the Lake Ellen Christian Church.

Article II - Purposes

The general nature of the object of the corporation shall be: To maintain regular services for the purpose of encouraging the worship of God: to urge the personal acceptance of the Lordship of Jesus Christ in every life, to promote systematic Bible study and training for Christian service; to urge the membership to live daily according to the principles set forth in the Scriptures; and to advance spiritual growth and enlightenment and moral and personal purity among its own membership and the people of the community in which it is located; and to educate, prepare and ordain Christian men and women for the ministry of the gospel of Jesus Christ.

Article III - Membership

Every person who believes in Jesus Christ, as Savior and Lord, and who is willing to confess Him publicly and follow Him in baptism; and to observe the ordinances of Christ and to be governed by His laws, is qualified and eligible for membership.

The present membership of the Lake Ellen Christian Church and those hereafter admitted to such membership shall constitute the membership of this corporation.

Article IV - Term

This corporation shall have perpetual existence.

Article V - Subscribers

The names and residences of the subscribers are as follows:

Article VI - Officers

This corporation shall have a Minister, Church Clerk, Church Treasurer and such other officers as may be authorized by the by-laws. Officers shall be elected as provided by the by-laws of this corporation.

In addition to the above officers, the corporation shall have a Board of Trustees consisting of not less than three (3) members, all of whom shall be elected by annually by a majority vote by the members

of the church. The church shall elect one (1) of their number as Minister, one (1) as Church Clerk and (1) as Church Treasurer. The Minister and the Church Clerk shall be authorized to execute all legal documents and instruments for the corporation; and all of the legal affairs of the church in their legal aspects only, shall be conducted by the Trustees.

The affairs of this corporation shall be managed by the Board of Trustees.

Article VIII - By-Laws

The by-laws of the corporation are to be made, altered or rescinded upon a two-thirds vote of the members present at any annual meeting of the corporation, or at any business meeting of the corporation provided that announcement of the proposed amendments, alterations, rescissions and the like is made from the pulpit on the two (2) Sundays previous to such business meeting.

Article IX - Amendment

Proposed amendments to these articles shall be first submitted to the officers and Board of Trustees at a regular or special meeting thereof attended by at least two-thirds of the active Trustees. If after consideration thereof, a majority of the officers and Trustees present at the meeting favor the proposed amendment, the appropriate officer shall present the proposal to the membership of the corporation at the next business meeting along with the recommendations of the Trustees.

Vote on the proposed amendment shall be taken at a subsequent business meeting, which shall be not less than two weeks after the initial presentation to the membership. A two-thirds vote of the members present shall be required in order to accept the proposed amendment.

Article X - Location

Location of this corporation shall be in the City of Casselberry, County of Seminole, State of Florida.

Article XI - Powers

In order to promote the purposes of this corporation, it may acquire property by grant, gift, purchase, devise or bequest, and hold and dispose of such property as the corporation shall require for the benefit of the members and not for pecuniary profit.

Article XII - Distribution of Assets upon Dissolution

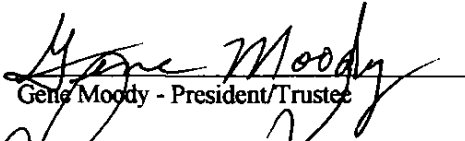
No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for

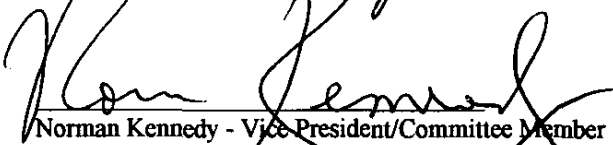

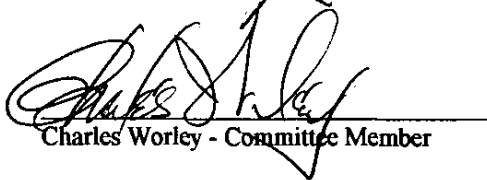
