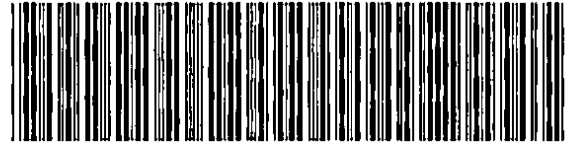

***Articles 9 and 10 of the Articles of Incorporation are amended to read as follows:***

9. By-Laws. The original By-Laws shall be made by the Board of Directors and/or declarer under the Declarations of Condominium. The same may thereafter be amended, altered or rescinded only with the approval of not less than a majority of the board of directors and not less than ~~75%~~ a majority of the ~~members~~ members voting interests of the corporation.

10. Amendment of Articles. These Articles of Incorporation may only be amended, altered or rescinded only with the approval of not less than a majority of the board of directors and not less than ~~75%~~ a majority of the ~~members~~ members voting interests of the corporation.
