THIS IS TO CERTIFY that the following is a true and correct copy of a resolution amending the Articles of Incorporation of SANTA FE COMMUNITY COLLEGE ENDOWMENT CORPORATION, INC., a Florida corporation, proposed and adopted by a unanimous vote of all the members present at a meeting of the Board of Directors of said corporation held on September 23, 2008 in Gainesville, Florida, at which a quorum was present:

WHEREAS, the Articles of Incorporation of SANTA FE COMMUNITY COLLEGE ENDOWMENT CORPORATION, INC. was filed on April 15, 1969 and amended on July 21, 1975, in the office of the Secretary of State of the State of Florida, and

WHEREAS, Article I of said Articles of Incorporation provides that the name of the corporation shall be "Santa Fe Community College Endowment Corporation, Inc." and

WHEREAS, such Articles of Incorporation provide in Article X thereof that such Articles of Incorporation may be amended by a vote of two-thirds of all members present at any meeting of the Board of Directors of said corporation, and

WHEREAS, the name of the educational institution being advanced by said corporation has been changed from SANTA FE COMMUNITY COLLEGE to SANTA FE COLLEGE, and

WHEREAS, it is deemed desirable in the opinion of all Directors present at this meeting of the Board of Directors of Santa Fe Community College Endowment Corporation, Inc. to change the name of the corporation to SANTA FE COLLEGE FOUNDATION, INC. by amending the Articles of Incorporation in Article I thereof to so reflect the change, and to refer to the educational institution in Article II of said Articles of Incorporation as Santa Fe College:

BE IT RESOLVED that Article I of the Articles of Incorporation of Santa Fe Community College Endowment Corporation, Inc. be amended to provide that the name of the corporation be changed from SANTA FE COMMUNITY COLLEGE ENDOWMENT CORPORATION, INC. to SANTA FE COLLEGE FOUNDATION, INC.

BE IT FURTHER RESOLVED that Article II of the Articles of Incorporation of Santa Fe Community College Endowment Corporation, Inc. be amended in line 6 thereof to refer to the educational institution being advanced as SANTA FE COLLEGE rather than SANTA FE COMMUNITY COLLEGE.

BE IT FURTHER RESOLVED that this amendment be filed with the Department of State for its approval.
