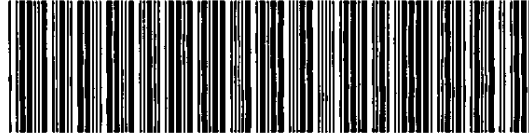

Article XII

Amendment voted on and approved by the congregation of Central Baptist Church on September 30, 2015 at the regular annual administrative meeting.

IN CASE OF DISSOLUTION – Upon the dissolution of the church, either for financial reasons, or by change of doctrinal stand, change to modernism, change to the contemporary or any movement which goes away from the Articles of Faith (in part or whole) and our historic Fundamental Independent Baptist position, the Board shall, after paying or making provision for payment of all the liabilities of the church, dispose of all assets of the church to such organization or organizations formed and operated exclusively for religious purposes as shall at the time qualify as an exempt organization or organizations under Section 501©(3) of the Internal Revenue Code of 1986, as the Board shall determine. Assets may be distributed only to tax exempt organizations that agree with the church Statement of Faith. Baptist International Missions Incorporated and The Sword of the Lord Publishers are recommended organizations; however, if at some time either of these shall go away from the faith and spirit of the above statements before Central Baptist Church of Ocala Incorporated is dissolved, then the remaining church leaders shall search a worthy Fundamental Independent Baptist Ministry to receive the church's assets.
