

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MURRY HILLS ASSOCIATION, INC. DOCUMENT NUMBER: 716446

Pursuant to the provisions of the Florida Not-for-Profit Corporations Act, Chapter 617 Fla. Stat. (2019) Murry Hills Association. Inc. adopts the following Articles of Amendment to the corporation's Articles of Incorporation, and states as follows:

FIRST: The name of the corporation is: Murry Hills Association, Inc.

SECOND: The corporation adopted an amendment to its Articles of Incorporation, specifically amending Article 3. Section 3.2 Paragraph "m," as follows (the language added is <u>underlined</u> and the language deleted is <u>struck out</u>):

The Powers of the Association will include and be governed by the following provisions:

m. To enter into cable, satellite, television, <u>video</u>, <u>internet</u>, and other signal <u>and data communication</u> <u>distribution</u> agreements, including providing easements for the agreements and assessing apartments/condominium units and members for the expenses of the agreements <u>allocated on a per-apartment/unit basis and collectable</u> as assessments.

THIRD: The Amendment was adopted by the corporation's Board of Directors on September 9, 2019.

FOURTH: The date of adoption of the Amendment by the corporation's members was October 15, 2019, and the number of votes cast for the Amendment was sufficient for approval.
